Getting to and from work safely:

- Only car share where persons live in the same household.

Arrangements within the premises:

- Hand sanitiser on all entry and exit points, must be used.
- Maintain 2m social distancing at all times where possible (desks relocated to achieve this).
- Compliance signage displayed around the premises.
- Avoid touching your face with your hands at all times.
- Single-person use of toilet facilities at any time.
- Door handles, light switches and work-surfaces cleaned daily.
- Wash your hands for a minimum of 20 seconds regularly throughout the day.
- Antiseptic wipes & sanitiser available around the offices for use.
- Single-person use of kitchen facilities. (Where practical bring your own lunch to work and do not share with others). Do not share mugs or cutlery, bring your own.
- No passing on the stairs or corridors.
- No un-authorised visitors allowed within the premises.
- All meetings to be held via telephone or video call.
- Report to your line manager if any works may entail working within 2m.

Additional arrangements within the factory:

- Protection screens installed around cut & screw beds.
- Welders working within their own segregated work-bay.
- Gloves to be worn at all times to avoid contact with multi-use surfaces and machines.
- Masks available if social distancing cannot be achieved for essential work.
- Delivery drivers to be instructed on arrival to sanitise and adhere to social distancing whilst on the premises.
- Non-contact deliveries where possible.

Additional arrangements for site based employees and contractors:



- Only travel to work if you are fit and well and have no Covid-19 symptoms.
- If you feel unwell during your site visit contact the office immediately for further instruction.
- At all times operatives must adhere to the main contractors or clients specific Health & Safety regulations as well as arrangements outlined in this document.
- Employees should avoid the use of public transport where possible.
- Where possible, employees will be encouraged to travel to site alone. Where this is not practical, operatives travelling in the same vehicle (max 2. persons) are to become a 'team' and only work alone or together. (No swapping with other colleagues).
- Use hand sanitiser before entering and upon leaving the vehicle. Ensure anti-septic wipes are used
 to sanitise the steering wheel, door handles, gear knob and any control mechanisms upon entry and
 exit within the vehicle. Masks not to be worn in the vehicle.
- Whilst travelling together, face forwards and leave the windows open/ajar for ventilation.
- Wash your hands for a minimum of 20 seconds when you arrive on site, when you return home and regularly throughout the day (ideally after each task and break).
- Upon entry to site only sign in and out with your own pen.
- Maintain 2m social distancing at all times while on site. This includes with other contractors, site staff and members of the public.
- Ensure adequate welfare facilities are available on site.
- Ensure correct PPE is worn on site at all times. Only wear your own PPE. If you need any additional PPE items, these are located within Harris Pipework stores. If you are unsure speak to your line manager who can provide this for you.
- Only use your own Hand & Power Tools on site.
- Where practical bring your own lunch to work and do not share with others. Ensure you bring your own mugs and cutlery etc. to use while on site. Do not share.
- Avoid touching your face on site, wearing a mask and/or gloves is optional unless;
- Gloves to be worn at all times when utilising multi-use surfaces, plant, machines and control mechanisms.
- Where essential work requires close contact out of social distancing guidelines, face masks and gloves should be worn at all times and mechanical aids used where possible. Where this is not possible – stop work immediately and refer to your line manager or site specific RAMS on how to proceed safely.
- Workers are advised not to stay away from home and allow adequate time for travel to and from site.
